
INFORMATION

The undersigned Assistant Provincial Prosecutor hereby accuses RESURRECCION RAVELO, MARLENE GONZALES, MONINA EUGENIO, FLORENCIA AREVALO, ALICIA TAMO, EDNA ESTALOZA, DANILO ARANDIA, JIMMY BEBAYO, JOEL YSULAN, REYNALDO FLITCHETRO, JOSEPH HERNANDEZ, RAMIL SALINAS, ADELAIDA BAGO, MA. VICTORIA BUERGO, MANUEL GARCIA and FERMIN GERONIMO BALINGIT of the crime of DIRECT ASSAULT UPON AGENTS OF PERSONS IN AUTHORITY, committed as follows:


That on or about the 25th day of September 2006, in the Municipality of Rosario, Province of Cavite, Philippines, and within the jurisdiction of this Honorable Court, the above-named accused, conspiring, confederating and mutually helping and aiding one another, knowing fully well that P/COL. JOSE JOEL SARASUA, P/MAJ. JOSE REDADA, JR., P/LT. JERRY BERN OLMILLO, P/SGT. WILLIAM TOLENTINO and P/SGT. EMERITA SAMPAYAN are members of the PEZA Police while NIXON GOMEZ, RONALD BURDEOS and EDGAR QUIREZ are Security Guards assigned at PEZA-Rosario, Cavite, by means of force, violence and intimidation, while armed with bladed/pointed weapons, did then and there willfully, unlawfully and feloniously attack, assault the aforementioned police officers and security guards while they were in the actual performance of their duties, thereby inflicting injuries on NIXON GOMEZ, RONALD BURDEOS and EDGAR QUIREZ, to the damage and prejudice of the said complainants.
