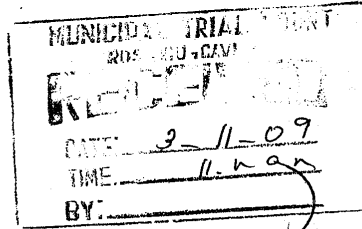

INFORMATION

The undersigned Assistant Provincial Prosecutor hereby accuses MERLY GRAFE, JIMMY EDER, NORMELITO GALON, ALONA OCTAVO, GEMMA GARABATO, RICARDO CAHANAP, CYNTHIA RED, CECILLE SABELA, ROSEBIE REMORIN, COLEEN MUYOT, BESSIE HERNANDEZ, JOEL YSULAN, ELSA BOBIS, ANALYN DIAZ, JOCELYN CUBILLO, AURORA AFABLE, of the crime of DIRECT ASSAULT UPON AGENTS OF PERSONS IN AUTHORITY, committed as follows:

That on or about the 27th day of September 2006, in the Municipality of Rosario, Province of Cavite, Philippines, and within the jurisdiction of this Honorable Court, the above-named accused, conspiring, confederating and mutually helping and aiding one another, knowing fully well that P/COL. JOSE JOEL SARASUA, P/MAJ. JOSE REDADA, JR., P/LT. JERRY BERN OLMILLO, P/LT ALEX BORJA, P/SGT. WILLIAM TOLENTINO and P/SGT. EMERITA SAMPAYAN are members of the PEZA Police while RONALDO ASAL, MIGUEL LIGTAS, RODEL COLLERA, ROMEO ALOSA, JOSE ALISBO, BENSON ESPINOSA and INIEGO PINGAL are Security Guards assigned at PEZA-Rosario, Cavite, by means of force, violence and intimidation, while armed with bladed/pointed weapons, did then and there willfully, unlawfully and feloniously attack, assault the aforementioned police officers and security guards while they were in the actual performance of their duties, thereby inflicting injuries on the security guards, to the damage and prejudice of the said complainants.
